Criteria and Rates for Scholarships Awarded to Non-Thai Students Pursuing a
Master of Science in Science and Technology Education (International Program)
Institute for Innovative Learning, Mahidol University
Academic Year 2026
B.E. 2569 (A.D. 2026)

It is hereby deemed appropriate to establish the criteria and rates for scholarships awarded to non-Thai students pursuing a Master of Science in Science and Technology Education (International Program) in an appropriate and structured manner.

By virtue of Clause 22.4 and Clause 23 of Mahidol University Announcement on Regulations and Methods to Receive, Maintain, Disburse, Pay, and Control Money, B.E. 2551 (A.D. 2008) and its amendment, which is under Clause 38 of Mahidol University Regulations on Administration of Budget and Finance B.E. 2551 (A.D. 2008) and its amendment and the resolution of the meeting of the Institute for Innovative Learning's Administrative Committee No. 4/2569 dated 27th February 2026, the Director of the Institute for Innovative Learning hereby has issued the announcement as follows.

Clause 1 In this announcement

"University" refers to Mahidol University

"Institute" refers to the Institute for Innovative Learning, Mahidol University

"Faculty of Graduate Studies" refers to the Faculty of Graduate Studies, Mahidol University

"Director" refers to the Director of the Institute for Innovative Learning, Mahidol University

"Program" refers to the Master of Science Program in Science and Technology Education (International Program) at the Institute for Innovative Learning, Mahidol University.

"Program Committee" refers to the committee appointed by the Dean of the Faculty of Graduate Studies, responsible for overseeing the administration and development of the Master of Science Program in Science and Technology Education (International Program).

“Student” refers to a non-Thai eligible individual enrolled in the Master of Science Program in Science and Technology Education (International Program) at the Institute for Innovative Learning, Mahidol University.

“Scholarship” refers to the financial award granted for further education in the Master of Science Program in Science and Technology Education (International Program) at the Institute for Innovative Learning, Mahidol University.

Clause 2 Scholarship Types and Rates

2.1 The Institute shall allocate funds as scholarships to support and encourage individuals with outstanding academic performance and high potential to pursue further studies in the Master of Science Program in Science and Technology Education (International Program), categorized into two types. as shown in Table 1.

2.2 Number of scholarships available:

Type 1: One scholarship

Type 2: Three scholarships

2.3 Scholarship duration: The scholarship commences in either the first or second semester of the 2026 academic year and is valid for a maximum period of **four semesters**.

Clause 3 Qualifications of Scholarship Applicants

3.1 The applicant must be enrolled in the Program for the 2026 academic year.

3.2 The applicant must hold non-Thai nationality. In cases of multiple nationalities, the final determination shall be made by the Director, based on the recommendations of the Program Committee.

3.3 The applicant must not have previously received nor currently be receiving any other scholarship from a university, faculty, college, institute, center, or external agency that is deemed similar in nature to this scholarship at the time of application. The determination of whether a scholarship is of a similar nature shall be at the discretion of the Director, upon the recommendation of the Program Committee, and such determination shall be considered final.

Clause 4 Scholarship Application Procedure and Required Documents

Scholarship applicants must complete the application process for the 2026 academic year through the Faculty of Graduate Studies system by May 31, 2026 (for enrollment in the first semester) or September 30, 2026 (for enrollment in the second semester). Additionally, applicants must submit the following supplementary documents to the Program Director prior to the interview date:

4.1 A letter of certification or official English proficiency test scores, meeting the Faculty of Graduate Studies' English proficiency requirement. The test scores must be issued within two years from the date the application fee is paid.

4.2 A Curriculum Vitae (CV) detailing the applicant's educational background, work experience, and any relevant experience in the field of education.

4.3 A problem statement of no more than 2,000 words in English, outlining the applicant's proposed graduate research at the Master's degree level. This statement should include the research problem of interest, proposed approaches to solving the problem, and the contributions and impacts of the research.

Clause 5 Scholarship Consideration Process

5.1 Upon receiving the supplementary documents for the scholarship application as outlined in Clause 4, the Education Subdivision of the Institute shall verify the completeness and accuracy of the submitted documents before presenting them to the Program Committee for consideration.

5.2 The Program Committee shall evaluate and select eligible scholarship recipients based on the qualifications specified in Clause 3 and the supplementary documents specified in Clause 4. The decision of the Program Committee shall be final.

5.3 Once the Program Committee has finalized the list of eligible scholarship recipients, the list shall be submitted to the Board of the Institute and the Director for approval. The names of the selected scholarship recipients will be officially announced on the Institute's website at <https://il.mahidol.ac.th>

Clause 6 Scholarship Disbursement

6.1 The disbursement of the scholarship shall be carried out in accordance with the announcement by the Faculty of Graduate Studies, regarding the disbursement of the Scholarship for Non-Thai Students Pursuing a Master of Science in Science and Technology Education (International Program), Institute for Innovative Learning, Mahidol University, Academic Year 2026.

6.2 The Institute shall disburse the Scholarship funds to the recipients as follows:

(1) Lump-sum tuition fees, international student health insurance, and thesis research fees:

- Each scholarship recipient must submit the tuition fee invoice issued by the Faculty of Graduate Studies to the institute's education officer every semester.
- The Program shall then request approval for disbursement from the Faculty of Graduate Studies through a fund transfer process managed by the Division of Finance, Official of the President, Mahidol University.

(2) Monthly stipend (Type 1 Scholarship):

- The Program shall request approval for the disbursement of the monthly living allowance from the Faculty of Graduate Studies.
- Each scholarship recipient must sign a receipt with the institute's education officer every month according to the Scholarship schedule.
- Once the Program receives the funds in its account, it shall transfer the funds to the recipients' bank accounts accordingly.

Clause 7 Conditions for the Scholarship Recipient

7.1 Each scholarship recipient is required to sign a scholarship agreement and any additional documents as required by the Institute.

7.2 During the Scholarship period

(1) Recipients must maintain good conduct and demonstrate diligence in their studies, refraining from neglecting, abandoning, suspending, or terminating their studies without valid justification during the scholarship period. The determination of misconduct or the validity of any justification shall be at the discretion of the Director, based on the recommendations of the Program Committee, and such judgment shall be final.

(2) Recipients shall not receive any other scholarship of a similar nature from any university, college, faculty, institute, center, or external agency. The determination of whether a scholarship is of a similar nature shall be at the discretion of the Director, upon the recommendations of the Program Committee, and such judgment shall be final.

(3) Scholarship recipients are required to perform assigned duties and/or participate in activities in support of the Program, Institute, or University. Recipients may additionally participate in related activities on a voluntary basis. The requirements are as follows:

(3.1) Recipients shall undertake duties or participate in activities, whether assigned or voluntary, that directly support, promote, or advance the mission, operations, and strategic objectives of the Program, Institute, or University. Such duties or activities may include, but are not limited to, those that enhance institutional visibility, public image, academic activities, academic initiatives, extracurricular activities, and other operational functions. Examples include:

- Preparing or contributing educational or academic content for official websites or publications;
- Undertaking studies, research, literature reviews, and the synthesis of knowledge derived from research articles or scholarly documents to support the development of academic initiatives and research activities.
- Participating in, assisting with, or organizing activities or events conducted by the Program, Institute, or University;

- Preparing and disseminating announcements, news, or public relations materials of the Program, Institute, or University through personal or official communication channels to enhance institutional visibility and support outreach to target audiences;
- Coordinating, facilitating, or providing support for academic services, projects, seminars, conferences, or related initiatives.

Recipients may be assigned additional duties or participate in relevant activities, whether assigned or voluntary, as deemed appropriate, provided that such duties or activities align with and support the mission and objectives of the Program, Institute, or University.

(3.2) Recipients shall complete no fewer than twenty (20) hours of duties and/or related activities per month throughout the scholarship period (24 months), beginning from the month in which the scholarship agreement is signed.

(3.3) Recipients shall perform all duties with due diligence, responsibility, and professionalism and shall remain accountable for the satisfactory fulfillment of such duties throughout the scholarship period.

(4) Academic Performance

(4.1) Recipients must maintain a GPA of no less than 3.25 each semester. If a recipient's GPA falls below 3.25 for two consecutive semesters or if the cumulative GPA falls below 3.25, the scholarship shall be subject to termination.

(4.2) Recipients must not receive a grade of U (Unsatisfaction) or F (Fail).

(5) For a scholarship recipient who receives a monthly stipend (Type 1 Scholarship), if a recipient is studying online, traveling abroad for research, data collection, attending meetings, seminars, internships, or returning to their home country for a period exceeding two weeks, they shall not be eligible to receive the monthly stipend for the duration of their absence. The stipend shall be resumed upon the recipient's return to Thailand, calculated on a daily basis based on the entry stamp date in their passport until the end of the academic year, in accordance with the Faculty of Graduate Studies' academic calendar. If the stipend has already been disbursed during the period of absence, the recipient must return the unused portion to the Program.

Clause 8 Suspension, Termination, and Revocation of Scholarship

8.1 The Institute shall suspend the disbursement of a scholarship to a recipient under the following conditions:

(1) If a recipient's GPA falls below 3.25 in any semester, the scholarship disbursement shall be suspended for the following semester. The scholarship may be resumed in the subsequent semester if the recipient's GPA for the suspended semester meets or exceeds 3.25.

(2) If a recipient takes a leave of absence for valid reasons, the scholarship disbursement shall be suspended for the duration of the leave. The scholarship shall resume in the semester in which the recipient re-enrolls.

8.2 The Institute shall terminate the scholarship under the following circumstances:

(1) If the recipient fails to comply with any of the conditions stated in the scholarship agreement.

(2) If the recipient voluntarily renounces the scholarship, is dismissed, resigns as a student, or takes a leave of absence without valid reasons.

(3) If the recipient exceeds the study period of three academic years.

(4) The Recipient is involved in any misconduct or has received any disciplinary actions according to the regulations of Mahidol University.

(5) The Program Director to which the Scholarship Recipient belongs requests the termination of the scholarship with reason to the Director of the Institute for Innovative Learning.

(6) The Recipient who has a GPA of less than 3.25 for two consecutive semesters, or a cumulative GPA of less than 3.25.

(7) The Recipient receives a grade U (Unsatisfaction) or F (Fail).

8.3 The Institute shall revoke the scholarship if it is discovered that the recipient did not meet any of the qualifications stated in Clause 3 from the beginning, or if the recipient is found to have used false documents or provided false information to obtain the scholarship.

Clause 9 Scholarship Reimbursement

In the event that the Institute terminates or revokes the scholarship in accordance with Clause 8.2 or 8.3, the recipient shall be required to reimburse the full amount of scholarship funds received to the Institute within the specified time frame determined by the Institute.

Nevertheless, if the recipient ceases to be a student due to death or any other reason deemed appropriate by the Director, based on the recommendation of the Program Committee, the recipient shall be exempt from the obligation to reimburse the scholarship funds.

If a recipient is required to reimburse the scholarship funds under this announcement but fails to do so or does not pay the full amount within the specified period, they shall be subject to a late interest fee of 5% per year on the outstanding balance, calculated from the due date until the full payment is made.

In cases where a recipient has not yet entered into a scholarship agreement under this announcement, but the Institute has already disbursed scholarship funds, the recipient shall still be required to return the full amount received to the Institute.

Clause 10 The Director holds the ultimate authority over this announcement. In case of any dispute, the Director's decision shall be final.

This announcement shall take effect as of now.

It is hereby deemed appropriate to revise the Announcement of the Institute for Innovative Learning, Mahidol University, titled “Criteria and Rates for Scholarships Awarded to Non-Thai Students Pursuing a Master of Science in Science and Technology Education (International Program), Academic Year 2026,” in order to ensure greater completeness and consistency in practice.

By virtue of Clause 22.4 and Clause 23 of Mahidol University Announcement on Regulations and Methods to Receive, Maintain, Disburse, Pay, and Control Money, B.E. 2551 (A.D. 2008) and its amendment, which is under Clause 38 of Mahidol University Regulations on Administration of Budget and Finance B.E. 2551 (A.D. 2008) and its amendment and the resolution of the meeting of the Institute for Innovative Learning’s Administrative Committee No. 8/2569 dated 11th May 2026, the Director of the Institute for Innovative Learning hereby has issued the announcement as follows.

Clause 1 The Clause 8 of the Institute for Innovative Learning Announcement titled “Criteria and Rates for Scholarships Awarded to Non-Thai Students Pursuing a Master of Science in Science and Technology Education (International Program) Institute for Innovative Learning, Mahidol University Academic Year 2026” signed on 5 March B.E. 2569 (2026), shall be cancelled and the following statement shall be applied instead:

“Clause 8 Suspension, Termination, and Revocation of Scholarship

8.1 The Institute shall suspend the disbursement of a scholarship to a recipient under the following conditions:

(1) If a recipient's GPA falls below 3.25 in any semester, the scholarship disbursement shall be suspended for the following semester. The scholarship may be resumed in the subsequent semester if the recipient's GPA for the suspended semester meets or exceeds 3.25.

(2) If a recipient takes a leave of absence for valid reasons, the scholarship disbursement shall be suspended for the duration of the leave. The scholarship shall resume in the semester in which the recipient re-enrolls.

8.2 The Institute shall terminate the scholarship under the following circumstances:

(1) If the recipient fails to comply with any of the conditions stated in the scholarship agreement.

(2) If the recipient voluntarily renounces the scholarship, is dismissed, resigns as a student, or takes a leave of absence without valid reasons.

(3) If the recipient exceeds the study period of three academic years.

(4) The Recipient is involved in any misconduct or has received serious disciplinary actions according to the regulations of Mahidol University.

(5) The Director of the Program to which the Scholarship Recipient belongs submits a request for termination of the scholarship, together with the supporting reasons and evidences, for consideration by the Director of the Institute for Innovative Learning.

(6) The Recipient who has a GPA of less than 3.25 for two consecutive semesters, or a cumulative GPA of less than 3.25.

(7) The Recipient receives a grade U (Unsatisfaction) or F (Fail).

8.3 The Institute shall revoke the scholarship if it is discovered that the recipient did not meet any of the qualifications stated in Clause 3 from the beginning, or if the recipient is found to have used false documents or provided false information to obtain the scholarship."

Clause 2 The Clause 9 of the Institute for Innovative Learning Announcement titled "Criteria and Rates for Scholarships Awarded to Non-Thai Students Pursuing a Master of Science in Science and Technology Education (International Program) Institute for Innovative Learning, Mahidol University Academic Year 2026" signed on 5 March B.E. 2569 (2026), shall be cancelled and the following statement shall be applied instead:

“Clause 9 Scholarship Reimbursement

9.1 In the event that the Institute terminates or revokes the scholarship in accordance with Clause 8.2 or 8.3, the recipient shall be required to reimburse the full amount of scholarship funds received to the Institute within 30 (thirty) days from the date of receiving the notification. If the Recipient fails to repay the full amount within the specified period or only makes a partial payment, it shall be deemed a breach of debt repayment obligations. In such a case, the Recipient shall be liable to pay the outstanding amount plus a delay penalty of 5 (five) percent per year, calculated from the day following the due date until the actual payment is made.

9.2 The Recipient shall not be liable to reimburse the Scholarship under this agreement in the following cases:

- (1) The Recipient's death.
- (2) The Institute determines that the Recipient is unable to continue his/her studies due to:
 - (2.1) Serious illness or disability, with a medical certificate, or
 - (2.2) A force majeure event, such as natural disasters, accidents, or political unrest.
- (3) Any other circumstance which, in the opinion of the Institute, is deemed to be a reasonable ground for which the Scholarship Recipient shall not be held responsible.

In cases where a recipient has not yet entered into a scholarship agreement under this announcement, but the Institute has already disbursed scholarship funds, the recipient shall still be required to return the full amount received to the Institute.”

This announcement shall take effect as of now.
